Pray, your learned-self, near & dear ones, Sah-Yogis and Sadhaks are doing fine!

You would be getting updates about the construction of Shri Ram Janmbhoomi Temple at Ayodhya. You are aware of the fact that for the last 30 years the road to Sri Aurobindo Ashram branch at Ayodhya has been under the control of the local police, that is, only with police permission it is possible to get access to the Ashram to have Darshan of the relics of the Maharshi enshrined there and also to visit the Ashram library.

The Uttar Pradesh government is constructing a new road to facilitate the huge pilgrim/visitor traffic heading to have Darshan of Shri Ram Janmbhoomi. This road, starting from the front of Birla Dharamshala and negotiating via the rear of Amava Ram temple, will go towards Shri Ram Janmbhoomi. Due to this road, difficulties will increase for the visitors to Maharshi Aurobindo Ashram.

You also know that the boundaries of the Maharshi Aurobindo Ashram and Shri Ram Janmbhoomi campus touch each other. It is our humble request to you to provide the present campus of Maharshi Aurobindo Ashram to Shri Ram Janmbhoomi Teerth Kshetra (a Trust formed by the Government of India). We will provide you with an alternative best site for building a new Ashram. The rest will be decided in consultation with you.




